This falls under #10.

I have worried about this for thirty plus years ever since going through 21% prime interest rates and government reported 13% inflation in 1980.

Most of us reading this have investments and one or more sources of "fixed income"

I have been very fortunate to meet and advise a number of people who have either made or inherited large fortunes (100 million or more).

Surprisingly, these folks share certain characteristics with most of us.

They worry about money; some of them to the extent that they still fear losing it all.

They want less government interference and regulation of their lives

They want to leave the world a better place than they found it

They respect and follow the law

They earned their money by hard work, and dedicated effort

Most of them have little faith in the public stock and bond markets

One man in Georgia has never held a share of stock in a brokerage account. The stock he owns is in his own company and some bank stock issued by a large national bank he acquired when he sold his interest in a local bank. He keeps the share certificates in a safe in his home. Most of you probably haven't seen a share certificate in four decades. Note: share certificates are hard to counterfeit, but stock held in street name represented by an electronic entry in your brokerage account can be counterfeited and sold or pledged to multiple investors.

Another Wisconsin man has never bought a share of stock in anything he did not control 100%. He learned how to evaluate, buy, run, and sell closely held companies and will only stop when he's called to the first tee in the sky. He said he might think of investing with Wall Street insiders if he had at least one billion but he is not quite there yet. In his mind Wall Street is as corrupt as the federal government

A California man learned the investment real estate business from a Chicago legend, then went on his own to build a half-billion enterprise that he controls.

His theory is why invest in someone else when you can control what you own and avoid lawyers and banks. He finances all his acquisitions by acting as his own banker. He told me that that the very best an stock investor can hope for is to break even with inflation, provided they don't pay commissions to a broker.

A friend in Michigan told me twenty years ago that I am the most cynical person that he has ever met. I give you all of this long-winded background as an introduction to a relatively new financial concept—digital currency.

Digital currency can be created with cryptographic algorithms and discrete mathematics. Digital currency exists only in cyberspace beyond the reach of governments who would either eradicate it or steal it. Since they can do neither, digital currency is a threat since it can't be devalued by governments and central banks they was the US Government and Federal Reserve system has ruined our money for 100 years.

Bitcoins are such a digital currency and they have created their own pundits, some pro and some con.

I'd be interested in what all of you think about the future of Bitcoins specifically or digital currency in general.
